Filing a Complaint Regarding Open Meeting, Public Records, and Conflict of Interest Requirements

Important Information:

This form is only for use for complaints regarding State Board of Education (SBE) authorized charter schools or charter management organizations (CMO) that operate a charter school authorized by the SBE. See additional information below to determine the charter school authorizer.

Education Code Section 47604.1

California *Education Code* (*EC*) Section 47604.1 requires that charter schools and those that manage charter schools (charter management organizations) comply with key state laws related to transparency and conflict of interest. More specifically, *EC* 47604.1 requires compliance with the Ralph M. Brown Act (open meeting law), the California Public Records Act (open records law), *Government Code* 1090 (law prohibiting conflicts of interest in purchasing or contracting) and the Political Reform Act of 1974 (law prohibiting conflicts of interest in government decision making). Before Filing a Complaint

The SBE takes its obligation to oversee SBE-authorized charter schools very seriously and, in doing so, has implemented a process for receiving complaints that an SBE-authorized charter school may have violated *EC* 47604.1. If the charter school is currently authorized by the SBE, or the charter management organization operates a charter school that is currently authorized by the SBE, you may use the form below to file your complaint. If your complaint pertains to an SBE-authorized charter school, but is unrelated to *EC* 47604.1, please submit your complaint to the SBE Oversight office at SBEOVERSIGHT@cde.ca.gov.

If you know that the charter school is currently authorized by a local school governing board or county office of education, we urge you to contact the authorizer to attempt to address your concern.
