On behalf of Sierra Vista Charter High School, the Tulare Joint Union High School District is requesting consideration of the following mitigating circumstances regarding our Nonclassroom-Based Funding Determination Request submitted for 2023-2024.

During the 2022-2023 school year, the district had difficulty both recruiting and retaining positions for our nonclassroom based charter school. Attached to this letter is a report called Assignment by Site, which was pulled from our position control system. This report lists all the positions at Sierra Vista Charter High School during the 2022-2023. The report lists dates to indicate which positions were vacant all or part of the school year. On the attachment, I have provided the number of months each position was vacant and the estimated amount of instruction and instruction-related expenditures that were not incurred during the 2022-2023 school year. In addition, per your request, I have indicated whether the vacancy was filled during the 2023-2024 school year.

The total estimated costs for these positions was \$404,510. When these costs are included in the funding determination calculations, the resulting of percentage of total revenues spent on instruction and related services (Calculation 2) is 72.56%.

At this time, and based on the above mitigating circumstances, I would request that Sierra Vista Charter High School be recommended for 85 percent funding.
